FULL -- \$295.00 (discount available if you are a first-time member of MPA – See ECP and New Member types below)

Requirements: Master’s level or higher degree in psychology and one year of experience practicing (Bachelor’s degree plus five years working may be approved, contact staff).

SUSTAINING -- \$410.00

Requirements: Must meet Full member requirements

EARLY CAREER PSYCHOLOGIST (ECP) - Tiered Membership – \$49 first year; \$96 second year; \$175 third year; \$225 fourth year; Full rate fifth year
